The Board of Fire Commissioners' Work Session was called to order by Chairman Work on **Saturday**, **January 15, 2022** at 0900 hours.

## PIERCE HEAVY DUTY RESCUE PURCHASE

Commissioner Work reviewed the replacement plan history which began in October 2015. The Rescue replacement discussions went dormant due to Chief changes and the COVID-19 pandemic with serious discussions with Pierce returning in 2021 after FDIC.

The new truck specifications, seating arrangements, design improvements and options are presented including:

- Velocity chassis.
- Cummins Diesel Motor.
- Enclosed command light.
- Rear door entry to command cab.
- Several cabinets for tools
- Stabilizer jacks to steady truck for camera mast and weather station
- Stairs at rear of truck.
- 4' longer than current Rescue 5.
- Improved turning radius.
- 360 degree cameras around truck.

Treasurer Larkin reports that a 12-year bond is recommended with the lowest interest rates available at this time. First payment would be due in 2023.

Commissioner Work reports a mandatory referendum is required to be held on Tuesday, February 22, 2022 from 6-9pm for voter approval of purchase. The legal notice will need to be published in the January 26<sup>th</sup> edition of the Clarence Bee.

## CHIEF TRUCKS REPLACEMENT PURCHASE

Commissioner Work reports that through the mini-bid process, Basil Chevrolet has 3 2022 Chevrolet Tahoe SSV vehicles available for purchase at a cost of \$122,046.00 with a March 2022 tentative delivery date.

No expenditure shall be made except upon authorization of the Board; and it is further RESOLVED, that this resolution is subject to a permissive referendum as provided by Section 6-g of the General Municipal Law. All in favor, motion carried.
